



CONTRACT 2011 Show

I hereby make application for booth space for sale purposes at Flatlanders Arts & Crafts Show on Saturday, September 3-4, 2011, and agree to abide by the following conditions:

- 1 I understand that I am responsible for the collection of all sales tax. State and local sales tax is 7 percent. The applicant understands that a reservation fee (\$75 for outdoor space, arts and crafts; \$85 for indoor space, fine arts; commercial promotions, \$85 for food, \$85 for children's activities, and \$40 for non-profits) is required for each exhibit space and must be sent with the completed Application/Contract. Also, new applicants must send photos in order for an application to receive consideration.
- 2 I agree to have my exhibit set up and ready for viewing promptly at 8:15 a.m. on the show's opening day, Sept. 3; I further agree that I will not dismantle my display prior to the end of the show at 5 p.m. on Sept. 4. All vehicles must be removed from the show area prior to 8 a.m. on opening day. I understand that I may begin setting up my display on Friday, Sept. 2, at 5 p.m.
- 3 I understand that no vehicles will be permitted to park immediately beside or behind exhibit booths during the show. I understand that I will be allowed to use a small trailer or some other rolling convenience that fits into my 12' x 12' booth space.
- 4 My arts and crafts work is all original and handmade; no kits or commercial molds are utilized in the creation of the work I exhibit. I agree to exhibit only the crafts and/or art media listed and agreed upon in this contract. Booth space allocated under this contract is for the exhibitor who signs the contract and may not be sub-leased to other people for display/sales purposes.
- 5 I agree to help keep and maintain show grounds, practicing safety rules, particularly fire safety.
- 6 I understand that I should bring with me all display props needed for my exhibit—tables, tent, table covering, racks, hanging materials, tools and/or folding chairs that I find necessary for setting up my display.
- 7 If for any cause whatsoever it becomes impossible to have the show, I understand this agreement is terminated, and I will waive any and all claims for damages.
- 8 Flatlanders Arts & Crafts Show, Lakeland-Lanier County Chamber of Commerce, City of Lakeland or Lanier County will not be responsible for any injury or loss that may arise or come to the exhibitor, or his employees or his goods, from any cause whatsoever, while show premises are being occupied under this agreement.
- 9 Flatlanders Arts & Crafts Show nor its sponsor will provide insurance; any insurance must be placed and paid by the exhibitor. I hereby relieve the management of the show of all responsibility in connection with the safekeeping of my property while said properties are at this show. I understand that there will not be any overnight security provided on the site of the show.
- 10 I understand that reservations will be confirmed by mail. No refunds will be made unless the application is not accepted.
